




# Names and functions of parts



### Front

- ① **() STANDBY/ON button:** Press this button to turn the unit on or put it in standby mode.
- ② NETWORK STANDBY LED: Lights when any of Network Standby, Bluetooth Wakeup, or Opt1 In Wakeup are on.
- ③ **INPUT SELECTOR control:** Selects the source to playback.Turn the control to switch the source in the following order; BD/DVD → SAT/CBL → AUX → GAME → SACD/CD → PHONO → TV → AM (SX-N30), DAB (SX-N30DAB) → FM → NET → BLUETOOTH
- ④ MEMORY button: Press this button to register a AM/ DAB/FM station.
- (5) TUNING MODE button: Press this button to switch the tuning mode for AM/FM broadcasts. Press also to select the DAB station display order.
- 6 DISPLAY button: Change the information shown.
- ⑦ SLEEP button: Press this button to set the sleep timer.
- ⑧ Display (⇒ 8)
- (9) SETUP button: Used to display the setup menu.
- (1) **ENTER button:** Press this button to confirm the selection.
- ① RETURN button: Returns the display to the previous state during setting or operation.
- 12 Direction/ I TUNING I / ← PRESET → buttons: Used to move the cursor. When listening to AM/DAB/FM broadcasting, tune in to the station with I TUNING I or select the registered station with ← PRESET →.







- CLR button: Use this button to clear the characters that you have input.
- SLEEP button: Press this button to set the sleep timer.
  - \* Operate with USB storage device play or the home network feature (DLNA, Home Media).




\* If you do not use the remote control for a long time, remove the batteries to prevent leakage. Note that keeping consumed batteries inside may cause corrosion resulting in damage of the remote control.



### Rear

- DIGITAL IN OPTICAL/COAXIAL terminals: Connected to players. Use a digital optical cable or digital coaxial cable for connection with the digital audio output jack of a player.
- ② FM UNBAL 75Ω/AM LOOP ANTENNA terminals (SX-N30), DAB/FM ANTENNA terminal (SX-N30DAB): The supplied antennas are connected.
- ③ LAN (10/100) port: Connect to the router with an Ethernet cable.
- ④ Wireless antenna: Used for Wi-Fi connection or when using a *Bluetooth* enabled device. Adjust their angles according to the connection status.




- (5) Power cord: Connect the power cord to an AC outlet. Disconnect the power cord only after putting the unit into standby mode.
  - \* Turning on the unit may cause a momentary power surge that might interfere with other electrical equipment on the same circuit. If this is a problem, plug the unit into a different branch circuit.
- ⑥ SIGNAL GND terminal: Connect if the record player has a ground wire.
- ⑦ LINE IN terminals: Connected to players. Use an RCA cable for connection with the LINE OUT terminal of a player.
- ⑧ LINE OUT terminals: Use when connecting recording devices, such as a cassette tape deck. Use an RCA cable to connect to the LINE IN terminal on a recording device.



### **Connecting speakers**



When connecting only one set of speakers, connect to the SPEAKERS A terminals as shown in the illustration. Make correct connection between the unit's jacks and speaker's jacks (+ to + and - to -) for each channel. If connection is wrong, a bass sound may become poor due to reverse phase.

Connect speakers with 4 Ω to 16 Ω impedance. You have to change the impedance setting if any of the speakers have 4 Ω or more to less than 6 Ω impedance. See setup menu "3. Hardware" - "Speaker Impedance" (⇔ 34).




Twist the wires of the speaker cable tightly before inserting into the terminals. After inserting the cables, tighten the terminals firmly by turning to the right.

### When also connecting to the SPEAKERS B terminals:

Connect using the same method described for SPEAKERS A. Connect speakers with 8  $\Omega$  to 16  $\Omega$  impedance to the both A/B terminals. In this case, change the impedance setting on this unit. See setup menu "3. Hardware"-"Speaker Impedance" ( $\Rightarrow$  34).

 Press the SPEAKERS A/B button on the unit or the remote control to switch the speakers. (The selection changes in the order SPEAKER A→SPEAKER B→SPEAKER A+B.)

#### When connecting a subwoofer:



Use a subwoofer cable to connect the SUBWOOFER PRE OUT jack to the LINE INPUT terminal on a subwoofer with built-in amplifier.

 Audio is not output from the SUBWOOFER PRE OUT jack when you set SPEAKER B as the speakers to output audio.


Connecting two or more cables to one terminal of a speaker

# **DIGITAL IN connection**

If the player has an optical or coaxial digital output terminal, connect using either a digital optical cable or digital coaxial cable to one of the DIGITAL IN terminals. To play, select the terminal name with the INPUT SELECTOR.




Note that this unit is equipped with an "Opt1 In Wakeup feature" so that when play starts on a player connected to the OPTICAL (GAME) terminal, this unit comes on and the INPUT SELECTOR automatically changes. (\$34)

- The DIGITAL IN terminals can only handle PCM signals.
- As the digital in optical jack of the unit has a cover, push in the cable straight against the cover as it is turned inside.

# LINE IN connection

Use an RCA cable to connect to the LINE OUT terminal on the player to one of the LINE IN terminal on this unit. To play, select the terminal name with the INPUT SELECTOR.




 Connect the record player (MM cartridge) to the LINE IN PHONO terminal. If the record player has a ground wire, connect it to the SIGNAL GND terminal of this unit. Note that if the connected record player has a built-in audio equalizer, connect it to a LINE IN terminal other than PHONO.

# Tuneln Radio

With the radio stations and the on-demand programs registered, Tuneln Radio is a service where you can enjoy music, sports and news from all over the world.



### **Playing back**

- 1. Press the NET button.
- Use the direction (∧/∨) buttons to select "TuneIn Radio" on the display and press the ENTER button.



- Press the direction (∧/∨) buttons to select a folder or menu item from the "TuneIn Radio" top list, and press the ENTER button.
  - The folders and menu items displayed on the top list are provided by the Internet radio service and categorised by genre, etc.
- Use the direction (∧/∨) buttons to select a radio station and press the ENTER button. Playback starts.
- If there are more than 10 items when you select a folder or menu, you can move through the list numbers 10 at a time each time you press the direction (</>) buttons.

#### Tuneln Radio Menu

If you press the MENU button or ENTER button while playing Tuneln Radio, the following Tuneln Radio menu items appear. To use each function, use the direction  $(\land/\lor)$  buttons to select a menu item on the display, and press the ENTER button. Menu items to be displayed differ depending on the broadcast station you are playing.

Add to My Presets: Registers radio stations and programs in your "My Presets" folder within TuneIn Radio. (When an item has been registered, the "My Presets" folder will be added to the "TuneIn Radio" top list.)

Remove from My Presets: Deletes a radio station or program from your "My Presets" folder. Clear recents: Clears all radio stations and programs from the "Recents" folder within "TuneIn Radio" top list.

Add to My Favorites: Registers radio stations and programs in "My Favorites".

 Other menu items include "View Schedule", which displays the program guide of radio stations and "Report a problem".

#### Regarding the TuneIn Radio Account


Creating an account on the TuneIn Radio website (tunein.com) and logging in it from the unit allows you to automatically add radio stations and programs to your "My Presets" folder on the unit as you follow them on the website.

To log in from the unit: Select "Login" - "I have a TuneIn account" in the "TuneIn Radio" top list on the unit, and then enter your user name and password. - You can pair with another *Bluetooth* enabled device by pressing and holding the ENTER button of the unit until "Now Pairing..." is on the display. This unit can store the data of up to 8 paired devices.



If "3. Hardware"-"Bluetooth Wakeup" (⇒ 34) is set to "On" in the setup menu, then once you start connection on a *Bluetooth* enabled device, this unit switches on automatically.





Update the OS version on your iOS device to the latest version before connecting it to this unit.

- Switch the Wi-Fi setting on the iPhone, iPod touch, or iPad on and then tap the AirPlay icon. Select this unit from the list of devices displayed, and tap "Done".



• The AirPlay icon is displayed in the control center if you are using iOS 7 and later. To display the control

center, swipe from the bottom of the screen of the iOS device.

- If the AirPlay icon is not displayed, confirm that this unit and the iOS device are both connected to the router correctly.
- 3. Play music files from an iPhone, iPod touch, or iPad. If the volume setting on the AirPlay enabled device is low, the sound will not be output from this unit, so adjust the volume to an appropriate level.

### Playback music files from a computer


- AirPlay is compatible with iTunes 10.2 or later.
- 1. Press the NET button.
- 2. Turn on your computer and start iTunes.
- Click the AirPlay icon of iTunes and select this unit from the list of devices displayed.
- 4. Play iTunes music files.

If the volume setting on the AirPlay enabled device is low, the sound will not be output from this unit, so adjust the volume to an appropriate level.

If "3. Hardware"-"Network Standby" (⇔ 34) is set to "On" in the setup menu, then once AirPlay starts, this unit switches on automatically and the "NET" input source is selected. Even if this setting is "Off", if the unit is already on then the "NET" input source is selected.

- Due to the characteristics of AirPlay wireless technology, the sound produced on this unit may slightly be behind the sound played on the AirPlay-enabled device.
- There may be some differences in how operations are performed depending on the iOS or iTunes version.


To use Spotify, you must install the Spotify app on your smartphone or tablet and create a Spotify Premium account.



If "3. Hardware"-"Network Standby" (⇔ 34) is set to "On" in the setup menu, then once Spotify starts, this unit switches on automatically and the "NET" input source is selected. Even if this setting is "Off", if the unit is already on then the "NET" input source is selected.

# Playing tracks stored on a USB storage device

You can connect a USB storage device to the USB port on the front panel and play music files on it.

 You can play high-res sources in formats such as WAV, FLAC, or DSD files distributed over the Internet. For information on supported devices and file formats, see "Compatible devices/media/file formats" (⇔ 40).



- 1. Press the NET button.
- 2. Use the direction ( $\wedge/\vee$ ) buttons to select "USB" on the display and press the ENTER button.




- Connect a USB storage to the USB port. When a USB storage is detected, "USB" appears on the display. If "USB" indicator flashes, check whether the USB storage device is plugged in properly.
  - Depending on the USB storage device, reading data from it may take some time.
  - If the media you connect is not supported or cannot be connected properly, the message "No storage" will be displayed.
- 4. Press the ENTER button. The name of the track or folder appears.

- Use the direction ( ∧/∨) buttons to select a track and press the playback (►) button.
  - If you have selected a folder, when you press the playback (▶) button, play starts from the first track in the folder. You can select tracks inside the folder by pressing the ENTER button.
  - Only the music files in the same level of the folder are played. You can also set repeat playback mode to Full and play all tracks stored on the USB storage device.
  - The USB port of this unit conforms to the USB 1.1 standard. Depending on the content being played, the transfer rate may not be sufficient, which can cause interruptions.

- You must connect the unit and PC or NAS to the same router.



  - streaming" to open a dialog box.
  - If media streaming is already turned on, select "More streaming options..." in the "Stream" menu to list players in the network, and then go to step 4.
- Click "Turn on media streaming" to list players in the network.
- 4. Select this unit in "Media streaming options" and check that it is set to "Allowed".
- 5. Click "OK" to close the dialog box.
- When using the Play To feature, open the "Stream" menu and check that "Allow remote control of my Player..." is checked.

### Playing music files by operating the unit

- Start the server (Windows Media<sup>®</sup> Player 11, Windows Media<sup>®</sup> Player 12, or NAS device) containing the music files to play.

 Use the direction (∧/∨) buttons to select the server and press the ENTER button.

The server folder will be shown.

- You can check the server name of your PC from the PC properties.
- Depending on server functions or sharing settings, some contents might not be shown.
- Use the direction (∧/∨) buttons to select the audio file that you want to play, and press the ENTER button or playback (►) button.
  - If information cannot be retrieved from a server, "No Item" will appear on the display. If this occurs, check the server and network connections.

# Using the Play To feature

Using a controller device or PC that complies with the DLNA standard, you can play music files stored on a server.

In this section, we explain the steps to perform remote playback with Windows Media $^{\textcircled{B}}$  Player 12.


- 1. Turn this unit on.
- 2. Turn on your PC and start Windows Media<sup>®</sup> Player 12.
- Select the file that you want to play in Windows Media<sup>®</sup> Player 12 and right-click it. This opens a pop-up menu.
  - To use the Play To feature with audio files on a different server, open that server from the list that appears under "Other Libraries" and select the audio file that you want to play.
- 4. Click the "Play to" and select this unit from the Play To list.

Open the Windows Media<sup>®</sup> Player 12 "Play To" dialog box, and start playback from this unit.

Use the "Play To" dialog box to control remote playback.

- Remote playback is not possible when you are performing a different operation that uses the network on the unit or playing a music file stored on a USB storage on the unit.
- If your PC is running on Windows<sup>®</sup> 8, click "Play To", and then select this unit.
- 5. Adjust the volume using the volume bar on the "Play To" dialog box.
  - The default maximum volume level is 64. You can change the level using Web Setup. For information on how to access Web Setup, see "Registering your favorite radio stations (My Favorites)" (⇒ 18) under "Listening to Internet radio".
  - Some times, the volume displayed on the "Play To" dialog box may differ from that appeared on the display of the unit.
  - When the volume is adjusted from the unit, the value is not reflected in the "Play To" dialog box.
- Depending on the version of Windows Media<sup>®</sup> Player, the names of the items you need to select may differ from the explanation here.

# Music streaming from a shared folder (Home Media)



A shared folder is configured in a network device such as a PC or a NAS device for access from other users. You can play music files in a shared folder on your PC or NAS device connected to the same home network as that of this unit. You can play high-res sources in formats such as WAV, FLAC, or DSD files distributed over the Internet. For information on supported devices and file formats, see "Compatible devices/media/file formats" ( $\Rightarrow$  40).

- You must connect the unit and PC or NAS to the same router.
- You must configure the relevant settings of the PC or NAS in advance. For information on the setup, see the instruction manual for each device. In this section, we explain the setup with Windows<sup>®</sup> 7 and Windows<sup>®</sup> 8.


# Setting up Windows Configuring the sharing options

- 1. Turn the PC on.
- 2. Select "Choose homegroup and sharing options" in the "Control Panel".
  - If the menu is not displayed, check that "View by" is set to "Category".
- 3. Select "Change advanced sharing settings".
- Check that the following radio buttons are selected in the "Home or Work" (Windows 7) or "Private" and "All Networks" (Windows 8):
  - "Turn on network discovery"
  - "Turn on file and printer sharing"
  - "Turn on sharing so anyone with network access can read and write files in the Public folders"
  - "Turn off password protected sharing"
- 5. Select "Save Changes" and click "OK" in the dialog box.

### Creating a shared folder


- 1. Select and right-click the folder to share.
- 2. Select "Properties".
- 3. Select "Advanced Sharing" on the "Sharing" tab.
- 4. Select the "Share this folder" check box and click "OK".

- 6. Select "Everyone" from the pull-down menu. Click "Add" and click "Share".
  - To set a user name and password to a shared folder, set "Permissions" in "Advanced Sharing" in the "Sharing" tab.






- Use the direction (∧/∨) buttons to select the server that you want to use and press the ENTER button.
  - You can check the server name of your PC from the PC properties.
- Use the direction (</>) buttons to select the shared folder that you want to use and press the ENTER button.
- 5. When a user name and password are required, input the necessary account information.
  - For information on how to input characters, see "Inputting characters" (⇒ 33) under "Various settings".
  - Use the account information set when you created the shared folder. After inputting the account information once, it is saved, so you will not need to input it the next time.
- Press the direction (∧/∨) buttons to select the music file to play and press the ENTER button or playback (►) button.

# Listening to the sound from a connected player



You can enjoy the audio from players such as televisions, Blu-ray disc players, and game consoles. See "Connecting a player" (⇔ 12) for connection.



- Switch the input source with the INPUT SELECTOR button to match the terminals you have connected the players to. (If you connected to the BD/DVD terminal, select "BD/DVD".)
- 2. Start play on the player.

If "3. Hardware"-"Opt1 In Wakeup" (⇔ 34) is set to "On" in the setup menu, then once play starts on a device connected to the OPTICAL terminal, this unit switches on automatically and the input source is selected.





### Tuning into stations automatically

- 1. Turn the INPUT SELECTOR control on the main unit to select "AM" or "FM" on the display.
- Press the TUNING MODE button so that the "AUTO" indicator on the display lights.
- - Searching automatically stops when a station is found. When tuned into a radio station, the "►TUNED◄" indicator on the display lights. When tuned into a stereo FM radio station, the "FM STEREO" indicator lights.

Band Frequency



When the reception of FM broadcasts is poor: If the radio wave reception is weak or there is excess noise in your location, refer to "Tuning into stations manually" on the next section to change the reception setting to monaural. This can minimise the noise and audio interruptions.

### Tuning into stations manually

If you tune into an FM radio station manually, it will be received in monaural sound.


- 1. Turn the INPUT SELECTOR control on the main unit to select "AM" or "FM" on the display.
- Press the TUNING MODE button so that the "AUTO" indicator on the display goes off.
- 3. Press the ♦ TUNING ♦ buttons to select the desired radio station.
  - The frequency changes by 1 step each time you press the button. The frequency changes continuously if the button is held down and stops when the button is released.
  - (SX-N30) You can change the AM frequency step. See "3. Hardware"-"AM Freq Step" (⇒ 34) of the Setup menu.

### Tuning into stations by frequency

It allows you to directly enter the frequency of the radio station you want to listen to.

- Press the TUNER button of the remote control repeatedly to select either "AM" or "FM" on the display.
- 2. Press D.ACCESS button.
- 3. Using the number buttons, enter the frequency of the radio station within 8 seconds.
  - To enter 87.50 (FM), for example, press [8], [7], [5], [0]. If the entered number is incorrect, press the D.ACCESS button again and re-enter the number.
- (SX-N30DAB) For other settings (⇔ 34, FM Search Lvl)

### Receiving RDS (SX-N30/SX-N30DAB)



RDS stands for Radio Data System and is a method of transmitting data in FM radio signals.

- RDS works only in areas where RDS broadcasts are available.
- In some cases, the text information appeared on the display is not identical to the content transmitted by the RDS station. Furthermore, unexpected characters may be displayed when the unit receives unsupported characters. However, this is not a malfunction.
- If the signal from an RDS station is weak, the RDS data may be displayed continuously or not at all.

**PS (Program Service):** Tuning into a radio station distributing Program Service information displays the radio station name. Pressing the DISPLAY button displays the frequency for 3 seconds.

**RT (Radio Text):** Tuning into a radio station transmitting Radio Text information displays text on the display of the unit.

**PTY (Program Type):** Allows you to search for RDS stations by program type.

**TP (Traffic Program)** (SX-N30): Allows you to search for radio stations transmitting traffic information.

### **Displaying Radio Text (RT)**

 Press the RT/PTY/TP button / PS/RT/PTY button of the unit once. The Radio Text (RT) is displayed scrolling across the display. "No Text Data" is displayed when no text information is available.

### Searching by Type (PTY)

- 1. Press the RT/PTY/TP button / PS/RT/PTY button of the unit twice.
  - The current program type appears on the display.
- Press the ← PRESET → buttons to select the type of program to search for.

The following RDS station types are displayed:



- 3. Press the ENTER button to search the radio stations of the selected type.
- When such a radio station is found, the indication on the display flashes. Then, press the ENTER button again.
  - If no stations are found, the message "Not Found" is displayed.

### Listening to Traffic Information (TP) (SX-N30)

- Press the RT/PTY/TP button of the unit three times. "[TP]" will be displayed if traffic information is transmitted by the radio station you are tuned in. "TP" only is displayed if no traffic information is available.
- 2. Press the ENTER button to search a radio station distributing traffic information.
- 3. When a radio station is found, searching stops and traffic information is received.
  - If no stations are found, the message "Not Found" is displayed.

### Tuning into stations

With the built-in tuner, you can enjoy DAB digital radio.

1. Turn the INPUT SELECTOR control on the main unit to select "DAB" on the display.

The very first time you select DAB, the Auto Tuning function automatically scans the DAB Band 3 for the multiplexes (i.e., stations) available in your area. Once the scanning process is complete, the first station that was detected is selected.

- To scan again, run the scan from "DAB Scan" (⇒ 34) in the setup menu.
- 2. Press the ♦ TUNING ♦ buttons to select the desired radio station.

### Sorting stations

You can sort the available stations alphabetically, by multiplex, or active stations.



# Presetting a radio station (SX-N30/SX-N30DAB)



It allows you to register up to 40 of your favorite radio stations. Registering radio stations in advance allows you to tune into your radio station of choice directly.

### Registering radio stations

- 1. Tune into the radio station you want to register.
- 2. Press the MEMORY button on the unit.
- Press the ← PRESET → buttons several times to select a number between 1 and 40 while the preset number is flashing (about 8 seconds).
- Press the MEMORY button again to register the station.

The preset number stops flashing and lights to indicate that the station is registered.

### Selecting preset stations

- Press the TUNER button of the remote control repeatedly to select "AM", "DAB" or "FM" on the display.

Try to disconnect and then connect again the power to the unit and router. This may solve the problem. If you are still unable to connect to the Internet, the DNS server or proxy server may be temporarily down. Check the service status with your ISP provider.

**Others:** Disconnect and reconnect the power cord, and retry updating.

# ■ Updating the firmware via USB connection

You need a 64 MB or larger capacity USB storage for updating.

# Precautions when updating the firmware

- Before updating, stop playback and disconnect anything connected to the USB port.
- While updating, never put the unit into standby mode, or disconnect the power cord or the USB storage being used for the update.
- Do not access this unit from a PC while updating.
- Updating takes about 30 minutes to be completed.
- Settings you made are retained after updating.

# Update procedures

- 1. Connect a USB storage to the PC that you are using and delete any files on it.
- Download the firmware file to the PC from our website. Decompress the downloaded file on the PC.The number of unzipped files and folders varies depending on the model.
- 3. Copy the decompressed files and folders to the root folder of the USB storage.
  - Do not copy any files other than the decompressed files. Do not copy the compressed file.
- 4. Press the NET button.
- 5. Use the direction ( $\wedge/\vee$ ) buttons to select "USB" on the display and press the ENTER button.
- Connect the USB storage with the decompressed files to the USB port.
  - Loading the USB storage takes about 20 to 30 seconds.
- 7. Press the SETUP button.
- Use the direction (∧/∨) buttons to select "7. Firmware Update" and press the ENTER button.
  - If it is not displayed, wait for a moment until the network feature starts.
- Use the direction (∧/∨) buttons to select "Update via USB" and press the ENTER button.
  - The option does not appear when no firmware update is available.

 Press the ENTER button with "Update" selected to start update.

"Completed!" is displayed when the update is complete.

- 11. Disconnect the USB storage from the unit.
- 12. Press the O STANDBY/ON button on the front panel to put the unit into standby.
  - Do not use the **(b)** STANDBY/ON button on the remote control for this operation.

The update is complete. The unit's firmware has been updated to the latest version.

# When an error message appears

When an error occurs, "\*-\*\* Error!" appears on the display of this unit. (Characters and numbers appear in place of the asterisks.) Refer to the descriptions below to check the meaning.

# Error code

\*-01, \*-10: USB storage device not found. Check whether the USB storage device or USB cable is correctly inserted to the USB port of the unit. Connect the USB storage device to an external power source if it has its own power supply.

\*-05, \*-13, \*-20, \*-21: The firmware file is not present in the root folder of the USB storage device, or the firmware file is for another model. Retry from the download of the firmware file.

**Others:** Disconnect and reconnect the power cord, and retry updating.


# Troubleshooting

# Before starting the procedure

Problems may be solved by simply turning the power on/off or disconnecting/connecting the power cord, which is easier than working on the connection, setting and operating procedure. Try the simple measures on both the unit and the connected device.

# Resetting the unit

Resetting the unit to the status at the time of shipment may solve the problem. If the measures mentioned in the troubleshooting do not solve the problem, reset the unit with the following procedure.



⊕ STANDBY/ON TUNING MODE

While the unit is on, press and hold the TUNING MODE button and press the STANDBY/ON button. "Clear" is displayed on the display, the unit enters standby mode, and the unit is reset to the state it was in at the time of purchase.

# Cannot turn on the unit.

- Make sure that the power cord is properly plugged into the wall outlet.
- Unplug the power cord from the wall outlet, wait 5 seconds or more, then plug it in again.

# The unit turns off unexpectedly.

• The receiver will automatically enter standby mode when AutoPowerDown or Sleep Timer is set and launched.

# There is no sound, or it is very quiet.

- Make sure the speaker set A or B is on. (⇒ 11)
- Make sure the correct input source is selected.
- If the MUTING indicator is shown on the display, press the MUTE button of the remote control to unmute the receiver.
- The PCM signal can be input only to digital input terminals. Make sure that PCM is selected on the playback component.
- Check the digital audio output setting on the connected component. On some game consoles, such as those that support DVD, the default setting is off.
- Make sure that the polarity of the speaker cables is correct, and that no bare wires are in contact with the metal part of speaker terminals.
- · Make sure that the speaker cables are not shorting.

 If your record player uses an MC cartridge, you must connect an audio equalizer and either an MC head amp or an MC transformer.

# Noise can be heard.

- Using cable ties to bundle audio cables with power cords, speaker cables, etc. may degrade the audio performance, so refrain from doing it.
- An audio cable may be picking up interference. Try repositioning your cables.

# Remote control does not work.

- Make sure that the batteries are installed with the correct polarity.
- If the remote control doesn't work reliably, try replacing the batteries. Don't mix new and old batteries or different types of batteries.
- Do not place obstructions between the main unit and the remote control. The remote control might not work if the remote control signal receiver on the unit is exposed to direct sunlight or bright light. If this occurs, try moving the unit.
- Beware that use of this remote control could cause the unintentional operation of other devices that can be controlled by infrared rays.
- If the unit is installed in a rack or cabinet with colored glass doors or if the doors are closed, the remote control may not work reliably.

# The display does not work.

# Cannot access to Wi-Fi (Wireless LAN) network.
